# Potential health effects

# Primary routes of exposure:

# 4. First-Aid Measures

# General advice:

First aid providers should wear personal protective equipment to prevent exposure. Remove contaminated clothing. Move person to fresh air. # 7. Handling and Storage

# Handling

### General advice:
